The undersigned, being a citizen of the United States desiring to form a non-profit corporation under the laws of the State of Ohio, does hereby certify:

<u>FIRST</u>. The name of the corporation shall be The Bluffs Homeowners Association, Inc.

SECOND. The place in this state where the principal office of the corporation is to be located is 5419 Silvertown Drive, Sylvania, Lucas County, Ohio 43560.

THIRD. The purpose for which said corporation is formed are as follows:
